

# **GREENSTOP INC. PRIVACY POLICY**

#### **ABOUT THIS POLICY**

GreenSTOP Inc. is a company incorporated in the State of Delaware, United States ("us," "we," "GreenSTOP," or the "Company"). This Privacy Policy ("Policy") applies to personal information that GreenSTOP collects and uses when you visit our website, use services we offer including advertising services, or use our in-store *Multi-interface Smart Machine* also known as *Multi-faced Automated Dispensary Kiosk* ("MISM")¹.

This Policy does NOT apply to information collected by any other third party companies and organizations such as dispensaries selling their products through the MISM, or to companies, organizations or individuals that advertise their products or services on our website or MISM, or whose products or services or websites or apps may link to our services, products, website or MISM.

By using our website or/and MISM you consent to our Policy.

## TYPES OF INFORMATION WE COLLECT AS YOU USE OUR WEBSITE OR MISM

When you use our website, services or MISM you are sharing your personal information with us, which may include (a) a first and last name; (b) a physical address; (c) an email address or other online contact information, such as a user identifier or a screen name; (d) a telephone number; (e) a Social Security number; (f) a date of birth; (g) a driver's license number; and (h) payment information ("Personal Information"). We understand that you are relying on us to protect your Personal Information, and we are committed to working hard to fulfill our responsibility to protect your Personal Information.

We also collect information about the interaction of your devices with our website, MISM and services including your IP address, crash reports, any products you may purchase from us, and the date, time and location of use.

### **OUR USE OF YOUR INFORMATION**

We use various technologies to collect and store your information, including cookies, pixel tags, local storage such as browser web storage or application data caches, databases, server logs, and cloud storage.

We may use the information, including Personal Information, we collect from you for any of the following purposes:

- providing, developing, maintaining, improving and personalizing our services, MISM, and website;
- registering you on our website;
- providing you with marketing communications and advertisements;
- handling your inquiries and requests;
- generating anonymous reports about use of the MISM and our website, and their features;
- allowing you to take part in competitions, campaigns, promotions or surveys;
- detecting, preventing, and responding to fraud, abuse, security risks, and technical issues that could harm the Company, our users, or the public;
- keeping you up to date by sending you our newsletters or email alerts;
- sharing your information, including Personal Information, if we have a good faith belief that
  disclosure, access, use, or preservation of such information is reasonably necessary to satisfy any
  applicable law, regulation, legal process, or enforceable governmental request, or to protect
  against harm to the rights, property or safety of the Company, our users, or the public as required
  or permitted by law;
- sharing your information, including Personal Information, with our affiliates, partners, and other
  trusted third parties that help us with customer support according to our specific instructions and
  compliance with this Policy and any other applicable contractual confidentiality and security
  obligations, policies and procedures;
- considering you for employment if you have provided personal information pursuant to an application for a job with GreenSTOP.

### **KEEPING YOUR INFORMATION SAFE**

GreenSTOP is committed to protecting the privacy, confidentiality, security, and integrity of the Personal Information that you share with us. Our MISM and website are built with strong security features designed to protect your Personal Information by automatically stopping security threats. These features include using encryption, and a robust protocol to keep your Personal Information private while in transit, regularly running security checks on our information collection, storage, and processing practices to block unauthorized access to our systems, and restricting disclosure of your Personal Information to the maximum extent possible under the law. If the Company detects a security risk that we believe you should know about, we will notify you.

Please note that your payment transaction is subject to review by the operator of our social payment system, and your funds could be frozen or removed and payment your transaction may be delayed or blocked or reversed based on such review by the social payment system operator.

#### **WE MAY USE COOKIES**

GreenSTOP does not use cookies, but some services integrated with GreenSTOP may. Please refer to the cookie policies for these services.

#### RETAINING YOUR INFORMATION

GreenSTOP retains the information we collect from you for different periods of time depending on what it is and how we use it, for legitimate business or legal purposes such as security, fraud and abuse prevention, or financial record-keeping.

### **ACCESS TO YOUR INFORMATION**

You have the right to request information about how GreenSTOP collects, uses, and discloses your information. You also have the right to access your information and request that GreenSTOP delete that information. You have the right to opt out of the sale of your information. You have the right to not be discriminated against for exercising your privacy rights.
